
Sarah's Circle helps approximately 800 women each year. We practice the Housing First Model and have no barriers to our programs. We are also growing.

Sarah's on Sheridan will serve as a vital resource for the entire city for many decades.

Our organizational and programmatic growth is due to the generosity of our partners, like you.
